Since its launch in 1995, the **Europa-Forum Wachau** and its salons offer participants the opportunity to **commit to the future of Europe** and to shape it through discussions on current challenges in a common and united Europe.

Between the **10th and 12th of June, 2021**, took place the the **2021 Europa-Forum Wachau**, along with the **Danube Salon** on the 11th of June, 2021. The intensive cooperation work in the Danube region was discussed in depth. The discussion revolves around the 10th anniversary of the **EU Strategy for the Danube Region (EUSDR)**, which is based on the promotion of the cross-border and transnational cooperation in the Danube Region.

The **Danube Rectors' Conference (DRC)** organizes a **summer school each year**, hosted by one of the DRC member universities. The **17th edition** of the DRC Summer School on Regional Co-operation, entitled **"Sustainable development in the Danube Region. Where we are and how we tackle future challenges?"** was to be held in **Cluj-Napoca, Romania** this summer.

Considering the **ongoing health situation** and the current circumstances related to the COVID-19 pandemic, we regret to inform you that **we have decided to postpone the 17th edition of the DRC Summer School to 2022.**

We are fully aware of the complexity of the challenges faced by universities at present, and therefore we have decided to take this step to save the additional efforts of all people involved. We very much regret this decision, since the DRC Summer Schools represent a long record of successful cooperation among young promising scientists from the Danube Region. However, we believe that the positive track of the DRC Summer Schools will be followed up next year when the situation is settled. #### 5. The Danube Day is around the corner



Each **29th of June**, the **Danube is celebrated** with the **Danube Day** by the 14 countries of the Danube River Basin. Don't miss this year's edition of the celebration organized by the **International Commission for the Protection of the Danube River (ICPDR)**, the European Commission and its partners.

Citizens of the region or anyone bound to the Danube are invited to gather around the river to **celebrate the second-longest river in Europe**. This day of joyfulness and festivities will also be used as a **reminder that despite its strength and power**, the Danube River embodies **a vital ecosystem** whose wetlands and unique floodplains, and its singular cultures and languages **need to be protected, promoted and brought to the spotlight**.

The Danube is an incredibly **multicultural river**. Indeed, it finds its **source at the heart of the Black Forest town of Donaueschingen** and flows further for some 2,850 km until it reaches its **mouth on the Black Sea**. On the way, the Danube River navigates through **9 countries** and witnesses the life of the **81 million European Citizens** that live in the Danube region - a place they call home.





Here is **what you can expect of the 2021 festivities**, organised by the ICPDR, which will be run under the motto "Discover Danube": river festivals on the banks of the Danube river, Danube Art Competitions, Green Danube Partnership, public educational events to awareness building on "cleaner and safer rivers", thought-provoking debates on innovation, science and research, exhibitions displaying the rich river biodiversity, presentation of uplifting youth projects and spectacular inter-generational meetings.

**This year's Danube Day will be held online**, due to the pandemic situation. Nevertheless, the Danube Day 2021 is a fantastic opportunity for Danube citizens, river basin management experts, and stakeholders to get together and **#HaveTheirSay in the direction of the Danube River Basin** for the next 6 years. The event will be opened by **Johann Strauß's "Blue Danube Waltz"**, as it has been the case since the 10th anniversary of Danube Day in 2004.

It will also be a way to **celebrate European Integration**, since **EU policies and initiatives** to protect the Danube **affect the lives of the people in the 14 countries** and are **a global model of success for river protection**.

## 6. Launch of MCU 2020 & 32nd Anniversary of the Magna Charta Universitatum



On **June 16 and 17, 2021** the **new Magna Charta (MCU 2020)** was signed for the first time. The event took place virtually in view of the travel restrictions imposed by the pandemic. **All signatories of the 1988 MCU had been invited to sign the 2020 version.** After the signature, signatories were invited to a virtual celebration.

During the signature event, **global perspectives** from international speakers about the current and anticipated **future environments facing universities** were discussed. Furthermore, participants talked about how the MCU 2020 to strengthen **the role of universities in the preservation of the planet and promoting health, prosperity and enlightenment** around the world.

Let's not forget that **the first Magna Charta was issued in 1988.** 388 Rectors, mostly from European universities, met in Bologna to sign it. It was meant to **enshrine the essential principles of autonomy, academic freedom, knowledge, research, and teaching**, on which the concept of mobility and free international exchange for students, researchers and academics is based. In the last decade, the signatory base has expanded significantly, involving an increasing number of universities from all over the world.

The **revised version of the Magna Charta** was prepared to reflect the **perspectives of both leadership and the whole academic community** and explicitly includes concepts such as diversity, inclusion, social responsibility and university citizenship.

## 7. Workshop on (non)participation of the Danube Region countries in Horizon 2020



On 18 June 2021, the **Priority Area 7 coordinators** organized an event to **contribute to enhancing the participation of the Danube countries in the European Research Area**. More specifically, the Priority Area 7 coordination team wanted to **assess the participation of Danube region researchers in Horizon 2020**.

This assessment is part of the updated **EUSDR Action plan**. To do so, the **Priority Area 7** coordination team issued two types of online questionnaires in 2020 :

- One addressed policymakers, oriented on defining the strengths and gaps in terms of (non)participation of researchers from particular countries (regions) in Horizon 2020 and/or other European grant schemes
- One dedicated to national contact points, agencies and/or applicants/potential applicants/and participants and other relevant stakeholders, focusing on the motives and barriers to the (non)participation in the Horizon 2020 program.

As a tangible result, an **analysis “Participation of the Danube Region Countries in Horizon 2020” was published**, describing the **participation patterns in Horizon 2020** and the possible **causes for the lower participation of researchers from particular Danube region countries**. In light of the conclusions from the above-mentioned Analysis, the EUSDR Priority Area 7 coordinators organized the **Workshop on (non)participation of the Danube Region countries in Horizon 2020 on June 18, 2021**.

This workshop aims at :

1. Introducing the analysis “Participation of the Danube Region Countries in Horizon 2020”.
2. Presenting the possibilities for the Danube region researchers to support their participation in Horizon Europe.
3. Discussing the best practices of the Danube Region on participation in research programs implemented on national level.
4. Identifying upcoming challenges and opportunities related to Horizon Europe from the perspective of the Danube Region, which will be serving as inputs for concrete policy recommendations in order to enhance participation of the Danube region countries in Horizon Europe

## 9. Call for participation: LOTUS Leadership Development Programme in learning and teaching

The call for participation in the **Leadership Development Programme** is now open under the Erasmus+ funded **LOTUS (Leadership and Organisation for Teaching and Learning at European Universities)** project.

The LOTUS project aims to contribute to **capacity building and strategic change management for learning and teaching at higher education institutions across Europe** and to discuss the potential of various actors to support transformation and innovation in learning and teaching.

The Leadership Development Programme helps European higher education institutions address key challenges in learning and teaching, by fostering capacity building in implementing systematic approaches to enhancement.





Under the call, **20-30 selected European higher education institutions** will participate in **peer-learning activities**, based on their own institutional priorities in learning and teaching. The Leadership Development Programme will **kick off with an induction workshop on 4-5 October 2021** and will **last until June 2022**. Over this period, participating institutions will **work on implementation and change management plans for learning and teaching**, while **exchanging with peer institutions** in a problem-solving approach and gain a comparative view of solutions proposed by different institutions across Europe to similar problems and challenges.
